POST TITLE: CLEANING OPERATIVE

WORKING HOURS: 12.5 HOURS PER WEEK

RESPONSIBLE TO: CLEANING SUPERVISOR

JOB PURPOSE:

To clean the designated areas in line with the schools quality procedures and work programmes in a safe and efficient manner.

MAIN DUTIES/RESPONSIBILITIES:

- 1. To clean all allocated areas which may include any or all of the following:
 - Toilets and washrooms
 - · Offices and classrooms
 - Corridors and walkways
 - Dining Area
 - School halls (please note this list is not exhaustive)
- 2. To respond to communication with pupils and colleagues in a polite and appropriate manner and in keeping with our code of conduct.
- 3. To ensure that a high standard of work is maintained in accordance with Quality Systems.
- 4. To comply with health and safety policy and systems, including COSHH regulations, report any incidents/accidents/hazards, and take a pro-active approach to health and safety matters in order to protect self and others.
- 5. To safeguard and promote the welfare of children for whom you have responsibility or come into contact with, to include adhering to all specified procedures.
- 6. The post holder must carry out his/her duties with full regard to the Trust's Equal Opportunities and Racial Equality Policies in the terms of employment and service delivery to ensure that colleagues are treated and services delivered in a fair and consistent manner.
